„Linee Guida per la gestione integrata del Ciclo della Performance degli Enti Pubblici di Ricerca pubblicate da ANVUR nel maggio 2015:

i. Ricerca Istituzionale

è: attività di ricerca svolte in conformità allo specifico mandato istituzionale (attività obbligatoria)

- finanziata principalmente attraverso il finanziamento ordinario statale
- inserita nella programmazione pluriennale sotto forma di obiettivi

produce: beni, servizi, pubblicazioni istituzionali e conoscenze di interesse del governo, di enti sovranazionali, della pubblica amministrazione, delle comunità scientifiche o dei cittadini

ii. Ricerca Scientifica

è: avanzamento nello stato del sapere a livello internazionale

- importante autofinanziamento
- limitata programmabilità

produce: pubblicazioni (+ brevetti, disegni, software, mappe, database etc.)

iii. Terza Missione

è: rapporto dell'ente con la società

produce: la messa a disposizione e la circolazione della conoscenza prodotta con l'attività di ricerca + formazione e avviamento alla ricerca

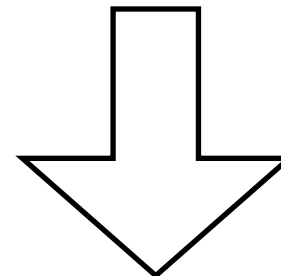
